## Compulsory information on the dissertation and public examination

Information on public examinations and online versions of dissertations must be accessible to the public at least 10 days before the public examination. Please send all information related to your public examination at least 15 days before the event.

The information will be published on LUT's website and intranet. Below is an example of the information we need in English and Finnish (we can help with the translation).

## Communicating the results of dissertations (possible media release)

The Communications team helps schools publicize their research results. One way to do that is to communicate about the outcomes of dissertation research. However, it is not worthwhile or feasible to prepare media releases on all dissertations. Decisions on media releases are made by communications specialists based on the information supplied by the doctoral candidate and possible further discussion.

To assess the dissertation topic's general appeal and potential for news coverage, we need the dissertation's abstract and easy-to-understand key points of the study (e.g., bullet points). Media releases are made primarily on studies connected to LUT's strategic focus areas.

Key points should explain what you have studied, what the importance of the study is (a problem you helped solve or an opportunity opened by the outcome), and the key results and their significance to an industry or society. Why should the so-called general public – people beyond your specific field of science – learn about your study?

The Communications team may ask more about your dissertation if needed and decides whether to publish a media release. The release can be one A4 sheet long, and it is edited by communications specialists. If we publish a media release, the doctoral candidate must provide a photograph and contact details for media.
